

Qualified Charitable Distribution **Checklist**

Follow these easy steps to make your QCD gift today! ☐ Contact your IRA custodian and request a Qualified Charitable Distribution (QCD) form ■ Complete your distribution form Most IRA custodians will not identify the donor that the QCD gift comes from, meaning that we won't know who made the gift or if there is a restriction for the gift. To ensure your gift is used in the way you intend, please instruct your IRA custodian to include your name and address on the memo line or check stub. Checks should be made out as follows*: If you are giving to the Annual Catholic Appeal, the check should be made payable to **Annual Catholic Appeal** If you are giving to To Teach Who Christ Is, the check should be made payable to To Teach Who Christ Is. If you are giving to Priests' Health and Retirement/PRMAA, the check should be made payable to Priests' Health and Retirement/PRMAA. ☐ If you would like your gift to support a program or ministry not listed here, please contact Karen Whitehead at 312.534.7461 or kwhitehead@archchicago.org for more information. ☐ Indicate where to send the QCD check Instruct your IRA custodian to send your QCD check to: Archdiocese of Chicago Karen Whitehead – Stewardship & Development 835 N. It usually takes 5-10 business days from the day your form is received by your IRA custodian to the day the charity receives the check.
